# **CECONOMY AG: Dr Kai-Ulrich Deissner takes over** interim CEO position until final clarification of successor to Dr Karsten Wildberger

- Experienced management duo takes over company management on an interim basis: Dr Kai-Ulrich Deissner becomes interim CEO, Remko Rijnders interim CFO
- Supervisory Board has initiated a structured search process for a long-term successor

**Düsseldorf, 8 May 2025** - The Supervisory Board of CECONOMY AG has initiated a structured search process for the long-term successor to the Chairman of the Management Board and has decided on an interim solution for the management of the company. Dr Kai-Ulrich Deissner will take over the management of the company as interim CEO and Remko Rijnders as interim CFO. CECONOMY AG is thus ensuring continuity and clear responsibilities in the company's management until a long-term successor has been established.

This decision follows the departure of Dr Karsten Wildberger, who had asked the Supervisory Board to release him at short notice by mutual agreement with effect from 5 May 2025. He is moving to the German Federal Government as Minister for Digitalisation and State Modernisation.

Dr Kai-Ulrich Deissner has been Chief Financial Officer (CFO) of CECONOMY AG and MediaMarktSaturn Retail Group GmbH since 1 February 2023. Previously, he held various CFO positions and management roles in sales and service at Deutsche Telekom, among others.

Remko Rijnders has been Chief Executive Officer (CEO) of MediaMarkt BeNeLux since 2020. Since 2023, he has also been Chief Operating Officer (COO) BeNeLux, Iberia, Turkey, Poland at MediaMarktSaturn Retail Group. He has held various management positions in the company since 2008 and in his current role has increased both profitability and customer satisfaction through data-based strategies.
